



PRIVACY POLICY

This privacy policy (the “policy”) explains how Bravo Industries, including all of its domestic and international subsidiaries (“Bravo,” the “Company,” or “we”), handles the personal information we collect through, or in connection with, the Company’s website located at <http://www.bravoindustries.com> (the “Site”). When you access the Site, you are consenting to the collection, transfer, manipulation, storage, disclosure, and other uses of your information as described in this policy. We encourage you to refer to this policy periodically so that you understand our current privacy practices. Your access of and use of our Site means you agree to the terms in this policy. WHAT DOES THIS PRIVACY POLICY COVER?

This Privacy Policy covers: (i) what personally identifiable information (“Personal Information”) we collect when you use or access the Site; (ii) how we use such information; (iii) our information sharing practices; and (iv) user preferences. This Privacy Policy does not apply to the practices of third parties that we do not own or control, including but not limited to any third party websites, services, applications, hardware, or equipment (“Third Party Services”) that you access through the Site or to individuals that we do not manage or employ. We encourage you to carefully review the privacy policies of any Third Party Services you access.

INFORMATION WE COLLECT

We collect information from a variety of sources, including information provided by you, information we collect when you visit our Site or offices, transaction information, and information we collect about you from third party sources.

The following are examples of the types of information we may collect:

- Information you provide;
- Information associated with the use of our Site (e.g. Bravo may use the information gathered from cookies and web beacons, such as IP address, to enhance your experience on our Site);
- Information associated with transacting business with us.

Information from Third Parties

If you access the Site through a Third Party source, including mobile applications such as Twitter or Facebook, we may automatically collect certain information that could include Personal Information, such as your name, picture, and email address.

User Content

In the future, the Site may allow you to provide content to Bravo, such as written comments (“User Content”). All User Content submitted by you to the Site may be retained indefinitely. Some User Content you upload may be viewable by the public or by other users of the Site, so we encourage you to consider your own privacy preferences when providing User Content.



Log Information

As a leading defense and logistics group, Bravo collects industry standard data from everyone who visits the Site. This includes log data that automatically records information about your visit, such as your browser type, operating system, the URL of the page that referred you, the different actions you performed, and the IP address you used to access pages on the Site. We use this type of information to provide you with an experience that is relevant to your location based on the IP address, to prevent fraud or misuse, to understand usage of the Site, and to ensure the Site is working properly. We do not share such information with any third parties.

Financial Information

We do not currently collect financial information. We reserve the right to collect such information through the Site in the future.

Information From Other Sources

We do not collect any information about you from other sources outside of your interaction with the Company and the Site.

Cookies

A cookie is a small piece of information sent by a website that is stored on your hard disk by your computer's browser. A web beacon is an embedded image on a website that monitors a website's activity. We do not currently utilize cookies but reserve the right to do so in the future.

Do-Not- Track

Currently, (i) other parties (e.g. third-party advertising networks and analytics providers) may not collect personal information about your online activities over time and across different websites when you use our Site or services, and (ii) we do not respond to, or take any specific action in connection with the receipt of, Do-Not-Track signals or other similar mechanisms regarding the collection of personally identifiable information about an individual consumer's online activities over time and across third-party websites or online services.

Analytic Tools

The Company is not currently using certain analytics tools on the Site but may, in the future, implement such analytics tools. However, data collected as a result of our use of such tools would only be used internally to enhance our users' experience using our Site and for our own business purposes. Such data may be shared with our partners and advertisers, if at all, only as aggregate information and as otherwise specified in this Privacy Policy. Please contact us if you have any specific questions regarding our use of any analytics tools.



INFORMATION SHARING

We may share your information within Bravo, and with Bravo's affiliates and subsidiaries. We also may share your information with third parties with whom we have a relationship. We may also share your information with third parties, such as companies that provide optimization services and services and tools related to analytics, to assist in the management of our Site and the data we may collect through the Site.

Information Disclosed for Our Protection and the Protection of Others

We reserve the right to share information with third party sources if we believe that disclosure is reasonably necessary to comply with a law, regulation, valid legal process (e.g. subpoenas or warrants served on us), or governmental or regulatory request, to enforce or apply the Terms of Use, to protect the security or integrity of the Site, and/or to protect the rights, property, or safety of Bravo, its employees, users, or others. If we are going to release your data, we will do our best to provide you with notice in advance by email, unless we are prohibited by law from doing so.

Information Security

We store all of our information using industry-standard techniques. We do not guarantee or warrant that such techniques will prevent unauthorized access to information about you that we store.

USER PREFERENCES AND OPT-OUT CHOICES

Resolution of Claims

Any complaints that are still unresolved after these direct efforts will be settled by arbitration administered by the American



Arbitration Association, at their offices located at 1776 I St NW #850, Washington, DC 20006 in accordance with its applicable commercial rules.
